**RECOMMENDATION FOR THE AWARD OF
LONG SERVICE (RSL) CERTIFICATE
(75 Years)**

A Long Service Award (75 Years Membership Certificate) may be awarded to any Service or Life Member who has given NOT LESS THAN 75 years CONTINUOUS service as a member of the League. A recommendation for the awarding of a Long Service Award can only be approved on the recommendation of the State Executive to the National Board.

A recommendation for awarding a Long Service Award should only be made when it has been established beyond a reasonable doubt that the recipient has been a financial member of the League for at least 75 years. The joining date of the member may be checked against the archived membership cards held at ANZAC House.
