



THE RETURNED & SERVICES LEAGUE OF AUSTRALIA

RECOMMENDATION FOR THE AWARD OF WOMEN'S AUXILIARY LIFE MEMBERSHIP

IN CONFIDENCE

The elevation of a member of the Women's Auxiliary to Life Membership of the Women's Auxiliary of the Returned & Services League of Australia is an honour that may only be approved by the National Executive on the recommendation of a State Branch.

The provisions governing Women's Auxiliary Life Membership can be found in National By-Law 5 and Victorian Branch By-Law 6, Part C, Rule 21. Branch By-Law 6, Part C, Rule 21 states that for a member to be elected to Life Membership of the Women's Auxiliary, the member must have at least 15 years continuous membership of the League and given at least 10 years outstanding service to the League.

Great care must be displayed when considering nominating a Member for the honour of Life Membership of the Women's Auxiliary. Life Membership of any organisation is a single honour of great importance and any nomination must qualify the nominated member beyond all doubt as to their outstanding service to the League through their Auxiliary.

A member nominated for Life Membership of the Women's Auxiliary should NOT be made aware that such nomination has been made until National Executive approval is received and advised by the State Branch to the nominating Sub-Branch and/or Auxiliary.

Citation Guidelines

The content of the Citation prepared by the Sub-Branch, Women's Auxiliary or Women's Council nominating a member for Life Membership of the Women's Auxiliary will strongly influence the decision of the Chairman and members of the Member Services Committee.

The Citation must clearly indicate that the member being nominated for Life Membership of the League has displayed long, continuous and outstanding service, to the Returned & Services League of Australia through their Women's Auxiliary. Outstanding Service to the League must be service beyond the normal expectations of a member, especially in an honorary capacity. (The fact that the member has been an office bearer or a member of the Women's Auxiliary Committee for a number of years on its own does NOT qualify a member for Life Membership).

It is particularly important that the efforts and dedication of the member's outstanding service in achieving the Charter & Purposes of the Sub-Branch and the Auxiliary to the betterment of veterans, their families and the community, are highlighted when writing the Citation. All aspects of the member's RSL and Auxiliary related activities must be included and expanded upon in the Citation.
