# Long Service – 60 Years

## Award for Long Service for Sixty Years Membership

A Long Service Award (60 Years Membership Certificate) may be awarded to any Service or Life Member who has given *not less than 60 years cumulative service* as a member of the League.

The provisions governing the Long Service Award can be found in the National Bylaws. A recommendation for the awarding of a Long Service Award can only be approved on the recommendation of the State Executive to the National Board.

A recommendation for awarding a Long Service Award should only be made when it has been established beyond a reasonable doubt that the recipient has been a financial member of the League for at least 60 years.
